Location

Wadhurst is a village situated approximately 5 miles South East from Tunbridge Wells. The train station is around 1 mile from the property and has a direct service to London with a travel time of approximately 1 hour. The property is in a prominent position, directly fronting the B2099, which leads directly to Wadhurst High Street. This is a predominately residential area

Description

The property has been operating as a beauty salon and comprises a reception / waiting area; leading to main shop / treatment area; through to two smaller treatment rooms; and a tanning room; and at the rear a further treatment room; and a WC. The treatment rooms have demountable walls and so the building has potential for open plan areas. At the rear there is a back door out to a small outside area.

There is a forecourt immediately to the front of the property to park a car.

The property is suitable for a wide range of alternative uses (subject to consent), and we consider there is potential to change the use to residential.
