# Location

Royal Tunbridge Wells is an affluent spa town, situated in North West Kent, and some 35 miles south east of central London, 19 miles east of Crawley, and 16 miles west of Maidstone.

There are good road links, with the A21 (T) linking through to the M25 at junction 5, around 15 miles to the north.

There is a fast and frequent train service to London stations with a typical journey time of 50 minutes to Charing Cross. London Gatwick is approximately 25 miles to the west.

# Description

A Grade II listed building, which was a public house for many years, and more recently ancillary to the Spa Hotel for staff accommodation. The building is now vacant.

The building is arranged over lower ground / basement, ground, first and second (roof) floors.

Planning consent has recently been granted for conversion to provide 3 houses.

# **Existing Accommodation / Floor Areas**

The main accommodation which comprises 9 studio / bed sit rooms, ancillary WC`s, a vacant bar and cellar area, totals 4191 sq ft, and together with the self-contained 1 bedroom flat, of 710 sq ft, there is a total gross internal area of **4901 sq ft** (455.4 sq m)
